STATEMENT ON THE COLLECTION AND USE OF PERSONAL DATA

By signing this Statement you agree to the collection, scope, manner of use and distribution of the collected personal information. Justification:

According to the Regulation on the protection of personal data (GDPR EU 2016/679 EUROPEAN PARLIAMENT AND COUNCIL of 27 April 2016) by issuing this document for goods / services purchased, we have collected your personal data about you:
